DEED OF TRUST

Subba Reddy, S/o P. Venkata Reddy, aged 26 years, resident of 27/97, Peta, Kurnool and (5) Sri R.V. Seshacharlu, S/o R. Seshacharlu, aged 58 years, resident of 46/749, Budhawarpet, Kurnool, hereinafter called TRUSTEES which expression shall unless repugnant to the context or meaning thereof be deemed to include survivors or survivor of them and the Trustees for the time being of these presents and their successors appointed by them.

4. The Trustees shall hold office during their life-time unless they vacate the Office earlier. G. Pulla Reddy / shall be the Managing Trustee during his life-time.

5. In the event of any vacancy arising in the Office of the Managing Trustee, by death, resignation or otherwise, the next seniormost Trustee shall act as the Managing Trustee, the seniority in respect of the Trustees herein being reckoned in the order in which the names of the Trustees are mentioned in the Deed.

6. In the case of vacancy in the Trust Board arising by death or resignation or otherwise, the remaining Trustees will have full powers to represent the Trust Board. The Managing Trustee shall have, in such an event, power to co-opt a Trustee to fill-up the vacancy.

7. The Trustees will be entitled and be at liberty to accept gifts or any voluntary contributions from any person, instal charity boxes and otherwise collect subscriptions or donations to augment the Trust fund and use such moneys for the objects of the Trust. It shall always be open to the Trustees in their absolute discretion to accept or refuse any such donations, gifts and or contributions.

The Trustee shall have powers to purchase and or construct properties, reconstruct the same or alter the property already on hand or those that may be acquired from time to time. The Trustees shall have powers at their absolute discretion to sell, call in, convert or pledge all or any of the properties movable or immovable of the properties movable or immovable of the Trust for the Trust purposes, purchase other properties or invest the Trust Fund in Government Securities or invest the Trust Fund in Government Securities or other such securities or Shares, Debentures or invest with individual parties with or without securities and on mortgages etc. and to vary such investments from time to time as they think fit.
